THE ASSAM PANCHAYAT (No. II) (AMENDMENT) ACT, 2002

AN

ACT

further to amend the Assam Panchayat Act, 1994

Preamble

Whereas it is expedient further to amend the Assam
Panchayat Act, 1994, hereinafter referred to as the
principal Act, in the manner hereinafter appearing:

XVIII of
1994.

It is hereby enacted in the Fifty-third year of the Republic of India as follows:

Short title, extent and commencement.

- 1. (1) This Act may be called the Assam Panchayat (Amendment)
 Act, 2002.
 - (2) It shall have the like extent as the principal Act.
 - (3) It shall come into force at once.

Amendment of section 3.

- 2. In the principal Act, in section 3,-
 - (i) in sub-section (2), (a) in clause (c), for the word "two-third", appearing in the first line, the words "fourth-fifth shall be substituted.
 - (b) clause (f) shall be omitted;
 - (ii) for the existing sub-section (5), the following shall be substituted, namely:-
 - "(5) The President of the Zilla Parishad shall be the Ex-Officio Chairman of District Planning Committee."

Renumber- 3 ing of section 3A and ommission of marginal note.

In the principal Act, section 3A(1) (2) and (3) shall be renumbered as sub-section (6), (7) and (8) of section 3 and the following marginal note of section 3A, so renumbered, shall be omitted, namely:

"Duties and function of the District Planning Committee."
